The majority of new construction or alteration projects are included in our Tier 1 rate. Should your project include Auditoriums, Schools, Churches, Hospitals, Nursing Homes or Transient Lodging (Hotel/Motel), please contact Atelier for a custom quote.

## TAS Package

This base package includes the required TDLR plan review and inspection fees. Our fees also include your project file set-up and correspondence with TDLR, along with one clouded plan revision responding to your initial plan review. (Additional revisions are subject to applicable fees). Travel is included within Dallas \& Tarrant Counties.

Projects may be pre-registered on-line. You may register your project at: https://www.tdlr.texas.gov/ABProjectRegistrationOnline/ If you would prefer our assistance, please include the administrative/filing fee of $\$ 200.00$ if not registered prior to submittal to Atelier.

Projects submitted after completion are subject to a TDLR Late Submittal Filing Fee of $\$ 300.00$ in lieu of the standard filing fee. Projects which do not include payment, completed registration form and construction document sets will not be scheduled for review until all items are received. The Request for Inspection form and inspection fees shall be submitted at time of plan review. Fees subject to change, please contact Atelier for current fee prior to your submittal.

## Preliminary Plan Review

We are able to review your preliminary plans at various stages in their development to aid in minimizing field changes and facilitate minimal final plan review comments. Invoiced at 75\% of review fee rate.

## Preliminary Inspection

To avoid costly corrections, Atelier inspectors are available to visit the site during construction to verify existing conditions, form boards and in-process work. Invoiced hourly, this reduces punch-list items and post occupancy work.

## Post Construction Inspection

Should your inspection note deficiencies, Atelier recommends our Registered Specialists field verify correction to items noted on your inspection report to ensure the items have been corrected to be in full compliance with the Standards. This includes a written summary with photo documentation for the owner's record.

## Public Information

Your data becomes public information with Texas Dept. of Licensing \& Regulation (TDLR) when registered. We are here to assist you through the various steps of your Accessibility review \& inspection. Solicitations are common and confusing in this process. Our Project Coordinator will identify themselves as being with Atelier and will notify you as the project nears completion to schedule the required inspection. Please contact our office should questions arise or if you are otherwise contacted regarding your project.

## Site Assessments

An assessment of an existing building can alert the owner to any existing non-compliant items that could become expensive legal issues in the future. This is also true when an owner is looking to purchase an existing property. Atelier can survey your facility and provide you with the information you need to keep your buildings in compliance with the Standards. Additionally, projects where 'primary function' spaces are altered are subject to additional requirements. The toilet rooms, drinking fountains, parking, and route to the alteration (including elevators) are subject to comply. An assessment of these existing items will identify potential concerns to include in the project budgets. Assessment fees are based upon project scope.
